


Risks and threats to a sustainable "science model"

Infringements of academic integrity

- Ordered results by industry / business / politics through "close connections"
- Double tongue, hidden commercial agenda, fraud
- Plagiarism, sloppy research, manipulating results, neglecting outliers etc.

Common denominator: claiming academic results where there aren't: "easy money".



Signs of decay

"Science is just an opinion (to buy)"

Lack of public trust

✓ Establish a code of conduct on ancillary activities

✓ Make academics observe the code of conduct

✓ Monitor compliance



Establish a code of conduct on ancillary activities

For all (academic) personnel,- main clauses:

- Ties with organizations outside university: in general good for inspiration and valorisation
- Potentially conflicting ancillary activities with business, industry, politics have to be registered
- Activities (and income): approval by dean needed

Core: choose the light of the day

Ties with companies etc. in itself are not a problem but intransparency about it is

Financial income from other parties is not a problem but harming universities interest is

- Publish all ancillary activities on public profile page
- Report all financial income to university

Keeping up academic integrity requires maintenance

✓ Establish code of conduct on ancillary activities

✓ Make academics observe the code of conduct

✓ Monitor compliance

Make academics observe the code of conduct

- Spread awareness on significance of the CoC
- Screen all ancillary activities in recruitment
- Require a yearly mandatory update of registration
- Provide a dedicated workflow with approval
- Put in place an adequate "escalation procedure"

Monitor compliance

- Check periodically actuality
 of register with subscriptions
 Chamber of Commerce






Dijkgraaf insists on public register for professors' side jobs
