Indeed, following the Association's General Assembly in April, the Board, Council and Secretariat embarked on a review of EUA's Strategic Plan, to take stock of the Association's achievements thus far this decade, plan for the future, and thereby build on what has been achieved during the tenure of former President Michael Murphy. This year also saw the approval of a <u>revised set of statutes</u> for EUA, following an extensive revision exercise overseen by the Statutes Review Group. These new legal documents will ensure that the Association has the governance and organisational structures in place to continue representing and serving its members effectively in the years to come.



Driving change

With European elections approaching in 2024, this year was also focused on preparations for the next mandate of the EU's institutions, which will be pivotal to the future of Europe and its university sector. Throughout 2023, EUA's <u>Universities and the future of Europe (UniFE) project</u> engaged in wide-ranging discussions on the future of Europe and our sector's place within it. Inspired by futures thinking and strategic foresight methodologies, the UniFE project explored likely influences on university cooperation for Europe's universities in the next decade.

Still looking forward to the coming years, in 2023 EUA also published dedicated agendas on university research and innovation, laying out the Association's priorities and planned actions in these key areas. New expert groups, drawn from EUA's diverse membership across Europe, also got to work on formulating the Association's position on the EU's next Research and Innovation Framework Programme, as well as guiding our work in increasingly prevalent areas such as digital transformation and academic careers.

In 2023, in addition to regular in-person events, online workshops and webinars, the Association's members and partners gathered at four major conferences, each hosted oncampus by one of our member universities.

2023 European Learning & Teaching Forum

Connecting people, spaces and realities

2-3 February | Bilbao, Spain

What can higher education institutions do to foster meaningful connections and collaboration within and across institutions, and with society, with a view to supporting successful learning and teaching? This key question was explored at the 2023 European Learning & Teaching Forum, hosted by the University of Deusto, while participants also considered the enhanced range of opportunities that blended, flexible and collaborative learning and teaching practices offer, as well as how they relate to student and staff wellbeing.

2023 EUA Annual Conference

We need to talk about impact

20-21 April | Gdańsk, Poland

Universities have a profound impact on individuals and societies, as well as the policies that govern both. In 2023, EUA's Annual Conference at Gdańsk University of Technology looked into how universities impact different communities and shape critical public policies. Exploring the various facets of universities' impact, the conference covered issues as diverse as rankings, excellence and the quest for quality, greening and sustainability, innovation and supporting endangered scholars and higher education systems, as well as the role of university leadership in delivering on various forms of impact.











2023 EUA-CDE Annual Meeting

Engaged research - the role of communication in doctoral education

14-16 June | Lahti, Finland

Focusing on the different dimensions of communication in doctoral education, the EUA Council for Doctoral Education's Annual Meeting, hosted by Lappeenranta-Lahti University of Technology and the University of Helsinki, addressed how to develop comprehensive approaches to including communication in doctoral education strategy and practices. As such, participants discussed communication both as an integral part of the doctoral candidate's journey and as a critical part of the daily activities of doctoral schools and programmes.


Internationalisation in a changing world

23-25 November | Aveiro, Portugal

Internationalisation brings both opportunities and challenges for quality assurance (QA). Therefore, EQAF 2023, jointly organised with the European Association for Quality Assurance in Higher Education (ENQA), the European Students' Union (ESU) and the European Association of Institutions in Higher Education (EURASHE) at the University of Aveiro, explored QA policies and practices that support new forms of internationalisation, addressing how QA can promote the long-term sustainability of transnational mobility and cooperation. Participants also considered whether or not the current European Standards and Guidelines and other European tools are fit for the future, and how the European framework can connect and compare with QA outside the EHEA.











University autonomy

Autonomy remains a necessary condition to enhance higher education institutions' ability to fulfil their core missions. Furthermore, the growing complexity of political and societal debates about university autonomy makes it all the more necessary to look at the issue through the widest possible lens.

Organisational autonomy

covering academic and administrative structures, leadership and governance

Staffing autonomy

including the ability to recruit independently, promote and develop academic and non-academic staff

Financial autonomy

covering the ability to raise funds, own buildings, borrow money and set tuition fees

Academic autonomy

including study fields, student numbers, student selection as well as the structure and content of degrees

In March 2023, EUA released the latest edition of its flagship series in this key area. <u>University Autonomy in Europe IV: The Scorecard 2023</u> provides an indepth analysis of university autonomy in Europe by collecting, comparing and weighting data on university autonomy in 35 higher education systems across the continent.

With findings across four dimensions of university autonomy – organisational, financial, staffing, academic – the Scorecard supports an evidence-based dialogue on this topic. This allows concrete benchmarking of national regulatory frameworks as well as the exchange of good practices. For the first time, the 2023 update also included a chapter on provisions for academic freedom in national legislation.

Building on the scores given in each dimension, the report identifies several notable trends across the 35 systems analysed. Beyond describing the evolutions in the different dimensions of autonomy, the report notably sheds light on the more complex interplay between the notions of autonomy and accountability.

Constrained internationalisation in an increasingly tense geopolitical context

Multiplication of steering instruments

The phenomenon is linked to the greater speed of public affairs and reactiveness of debates in the public sphere, often leading public authorities to seek 'faster' routes to results and impact via targeted interventions that tend to impact institutional autonomy.

Three higher education systems (Georgia, Romania, Scotland) feature in this edition for the first time, alongside four returning systems (Cyprus, Czechia, Greece, Türkiye). This extended coverage enables better comparability as well as the possibility of drawing more comprehensive Europe-wide conclusions. Hungary is the object of a complementary analysis.

Following the publication of the main report, country profiles were published in <u>October</u> and <u>December</u>, further delving into in-depth system analyses, offering insights into recent developments and presenting the sector's perspective in individual systems.



Advocacy

EU policy priorities

EUA is an established actor in informing and influencing European Union policies on higher education, research and innovation. In 2023, the Association paid close attention to the EU's overarching ambitions, as well as a wide range of topics and programmes central to the interests of universities, including the European Green Deal, Erasmus+, the European Universities Initiative and Horizon Europe. In addition, a year-long project – 'Universities and the future of Europe' (UniFE) – engaged in an in-depth consultation process with EUA's membership to inform the Association's engagement around the European elections in 2024 and overall approach to European policy making in the years to come.

A Green Deal roadmap for universities

The European Green Deal provides a policy framework to integrate the scientific, educational and institutional dimensions of universities' contribution to the green transition. To this end, EUA published 'A Green Deal roadmap for universities' in October, informed by the work of a dedicated task-and-finish group.

The roadmap outlines how universities can contribute to a climate-neutral, environmentally sustainable and socially equitable Europe. Universities are in a unique place to achieve this, bringing together researchers, innovators, public and private sectors, as well as their surrounding communities. Leveraging these assets effectively also requires transformative action within our sector, which the roadmap outlines under four overarching areas: 1) Research & innovation; 2) Education & students; 3) Staff & operations; 4) Public engagement & societal impact.

European policy processes and the global context

EUA actively contributes to the development of the European Higher Education Area (EHEA) – through active participation in the Bologna Process – as well as the EU's European Education Area (EEA) and European Research Area (ERA). Further afield, the Association regularly participates in dialogue and cooperation initiatives with international partner organisations, including through the Global University Associations Forum (GUAF). In 2023, supporting university communities in Ukraine, including EUA's growing membership in the country, was again to the fore of the Association's activities.

In focus

Supporting the Ukrainian university sector

A well established, internationally connected higher education and research sector is of vital importance for the overall resilience of Ukraine and its ability to reconstruct and reform. In July, EUA published a <u>set of recommendations</u>, based on the work of its Ukraine Task Force, outlining how wartime support for Ukrainian higher education and research must shift from emergency relief to more sustainable and long-term support measures.

EUA is also a partner in the MSCA4Ukraine project. Funded under the EU's Marie Skłodowska-Curie Actions/Horizon Europe and led by Scholars at Risk Europe, the scheme <u>supports 124 researchers in 21 host countries</u>. For students from Ukraine and beyond, EUA will continue to advocate for the establishment of a dedicated programme for students with a refugee(-like) background as part of Erasmus+.



Higher education

Establishing a European dimension in higher education learning and teaching is at the heart of many EUA initiatives – as is enhancing the quality and relevance of higher education provision. Guided by EUA's Learning & Teaching Steering Committee, the Association underlines the importance of learning and teaching as a core mission of universities, student learning and success and the recognition of teaching as a central part of the academic profession. In 2023, the impact of new digital technologies was central to debates about the future of higher education, and indeed, many of EUA's L&T activities (learn more in the *Digital transition* section below).

Moreover, as a leading voice on quality assurance, EUA maintains dialogue with policy makers and other key stakeholder organisations, specifically its partners in the E4 group (ENQA, ESU and EURASHE), and supports the operations of the European Quality Assurance Register for Higher Education.





System and institutional development

In focus

Supporting European universities in their strategic approaches to digital learning

2023 saw the launch of the final outcomes from the Erasmus+ funded <u>DIGI-HE project</u>, delivered through events, publications and online resources.

DIGI-HE explored different ways that higher education institutions can boost their strategic approaches to digitally enhanced learning and teaching and enhance their capacity, a task made ever more pertinent by the Covid-19 pandemic and its aftermath. It did so by encouraging reflection on institutional strategy development and enhancement, good practice sharing and peer learning among university leadership, and community building.

Research and innovation

EUA actively promotes the pivotal role of universities in research and innovation and supports universities in the transition to Open Science. 2023 saw notable work on research careers and assessment, scholarly communication, research ethics and the European Research Area. EUA's activities in this area are guided by the Research and Innovation Strategy Group, as well as respective Expert Groups on Open Science and Innovation, with the publication in 2023 of dedicated agendas outlining the Association's priorities and actions on innovation and university R&I in the coming years.

In focus

Seizing the moment and driving the change for university R&I

University R&I, and its synergies with education and service to society, is the premier gateway to the knowledge and skills needed for scientific progress and sustainable societal development. With vital discussions underway regarding funding frameworks, regulations, careers and infrastructures, in December EUA published its 'EUA Research & Innovation Agenda 2027', a catalyst for strategic reflection in the sector and mobilisation of universities as they navigate and shape the R&I landscape in the coming years.

The Agenda promotes a wide-ranging enhancement and closer integration of universities' capacities as leading R&I actors built around three priorities for the Association: Amplifying the societal impact of university R&I; Cultivating robust, diverse and collaborative R&I culture(s); and Championing a well-designed and sustainable R&I system.

System benchmarking, leadership, governance and management

As universities operate against diverse and rapidly changing regulatory, financial and societal backdrops, important insights can be gained through the comparative analysis of different frameworks across Europe. In 2023, EUA published the latest edition of its Autonomy Scorecard.

Closely interlinked with EUA's work on autonomy and governance are the Association's efforts to support universities in developing the capacity to make the best possible decisions. Following the successful conclusion of the NEWLEAD project, EUA announced plans to design a leadership development programme for European university leaders.

In focus

Innovative leadership and change management in higher education

Leading and transforming universities is a complex endeavour, requiring a diverse skill set, adaptability, and the ability to navigate through ever-evolving challenges. Leadership and management are also among the many prerequisites to reaping the benefits of institutional autonomy and address today's big transformation agendas. To succeed in these endeavours, universities must foster leadership development throughout the institution, including academic and professional support leaders.

2023 saw the release of the final outcomes from the Erasmus+funded <u>NEWLEAD</u> (<u>Innovative Leadership and Change Management in Higher Education) project</u>, all of which are available in a dedicated online repository. These underline the importance for upscaling support for the development and implementation of leadership development programmes for university leaders.





EUA Council for Doctoral Education

The Council for Doctoral Education is an integral part of EUA, and a leading voice in doctoral education in Europe. It is the largest European network in this field, covering more than 280 universities and institutions working on issues related to doctoral education in 39 countries. Launched in 2008, EUA-CDE works with its members to strengthen their doctoral education capacity and to prepare the next generation of Europe's researchers for the challenges with which the world is now confronted. The Council's work is guided by the <u>EUA-CDE Steering Committee</u>. In 2023, an EUA-CDE Thematic Peer Group on 'Profiles and institutional support for postdoctoral researchers' explored how to further enrich the experience of postdoctoral researchers, with the group's findings set to be published in 2024.

Institutional Evaluation Programme

Since its launch in 1994, the Institutional Evaluation Programme (IEP) has supported over 340 institutions in 50 countries in developing strategic leadership and capacity to manage change through a process of voluntary institutional evaluations. The programme prides itself on its contextsensitive approach, offering comprehensive, improvement-oriented institutional evaluations conducted by a team of experienced higher education leaders.

IEP is registered as a quality assurance agency on the European Quality Assurance Register for Higher Education (EQAR). It is led by a dedicated Steering Committee, and its pool of 50 experts is composed of current or former university leaders, as well as experienced higher education professionals and students from right across the European Higher Education Area.

In a targeted review conducted between 2022 and 2024, the European Association for Quality Assurance in Higher Education (ENQA) found IEP compliant with the Standards and guidelines for quality assurance in the European Higher Education Area (ESG). In addition, IEP is currently developing a new, ambitious strategic plan for the period 2025-2030.

Governing bodies

EUA is governed by a General Assembly, Council, Board and Presidency.

General Assembly

The EUA General Assembly is comprised of all full and associate members, although only full members are entitled to vote. The General Assembly is the highest governing body of the Association, and it elects the President and Board. On 20 April 2023, the 25th EUA General Assembly took place in Gdańsk, Poland, prior to the Association's Annual Conference.

Council

The <u>EUA Council</u> is comprised of the Association's President, the members of the Board and the chairperson or nominated representative of each collective member. The Council meets to discuss and define EUA's priorities and to endorse various policy positions and statements. In 2023, it convened on three occasions.

Board

The <u>EUA Board</u> is comprised of the President and eight members, including the two Vice-Presidents, all of whom are current or former university rectors. The Board is responsible for the preparation and implementation of the Association's policy and the planning of its activities. In 2023, it met on five occasions.

During the 2023 EUA General Assembly, Josep M. Garrell, former Rector of Ramon Llull University, Spain, was elected as the Association's president, succeeding Michael Murphy, former President of University College Cork, Ireland.

Secretariat

The <u>EUA Secretariat</u> is based in Brussels and Geneva. The Secretary General, Amanda Crowfoot, is responsible for running of the Secretariat, which ensures the daily management and implementation of all EUA activities.

As part of its work, the Secretariat also coordinates a variety of <u>EUA working groups and steering committees</u>, which draw on the expertise of EUA members to guide the Association's initiatives in specific areas.

Membership

In 2023, EUA reached a total of 875 members in 49 European countries.

Members and Affiliates

EUA offers three different membership categories.

Individual Full Members

Higher education institutions that conduct research, award degrees in at least two of the three study levels, and are financially viable.

Collective Full Members

The recognised representative bodies of universities (national rectors' conferences) in their respective country.

Individual Associate Members

Financially sustainable higher education institutions that award degrees at the first and second cycle level, but do not meet the research criteria as set for Individual Full Members, or organisations whose primary focus is research, but which also carry out some teaching.

What if EUA membership isn't an option for your organisation?


Organisations with an interest in European cooperation in higher education, and which are supportive of the mission and aims of EUA, may apply to become an EUA Affiliate.

There are two types of Affiliates:

- * Organisations are single-entity organisations that support higher education institutions in carrying out their missions, as well as other kinds of organisations active in the field of higher education or research.
- * Networks are collectives of higher education institutions, including other university networks or associations or university alliances.


Finances


