The European Quality Assurance Forum (EQAF) provides a platform for discussion, professional development and exchange of experiences among the main stakeholders in quality assurance (QA). Specifically, the Forum will be of interest to rectors and vice-rectors responsible for QA, QA officers in higher education institutions, students, QA agency staff and researchers working on higher education or the QA field.

Through a mix of plenary and parallel sessions, the 2018 EQAF, entitled '**Broadening the scope of QA**', will combine practice-oriented or research-based discussions that will take place in the paper sessions and workshops with presentations of current developments in quality assurance. The Forum provides an opportunity for participants to update their knowledge and extend their professional development.

#### Forum objectives

As a tool for supporting the quality of higher education, QA has in many European higher education systems focused largely on learning and teaching. However, as underlined in the introduction to the *Standards and guidelines for quality assurance in the EHEA (ESG)*, higher education institutions should have QA policies and processes that cover other institutional activities, and in parallel, external QA is increasingly looking into these policies. This edition of EQAF will explore how institutions and QA agencies can build QA systems that encompass a broad range of activities, including learning and teaching, research, governance and administration, and service to society.
